NEW MEMBERS DISCOUNT.

NEW MEMBERS OR MEMBERS RETURNING AFTER A GAP OF 5 YEARS WILL BE ELIGIBLE FOR A ONE OFF INTRODUCTORY DISCOUNT OF 10% WHICH WILL BE PAID AS A CREDIT TO THE NEW MEMBER'S BAR CARD.

The MEMBER GET MEMBER SCHEME applies where an amount of up to £50 is paid to members in the form of a credit on their bar card, following the introduction of a new full adult member (Contact the Club Office for details).

All age brackets are calculated on the age of the person on 1st April 2017.

PAYMENT OF SUBSCRIPTIONS.

- Current subscriptions are posted on the Club notice board, listing the categories of membership and their respective subscriptions rates.
- Subscriptions are due on 1st April 2016. Note: Once you have played on or after 1st April 2016 you are deemed to have rejoined and are liable for the full year's subscription.
- Subscriptions may be paid by:
 - a. One payment to be made by 1st April 2017 or
 - b. Direct Debit with 12 equal monthly payments. The direct debit amounts will be taken on the 1st of each Month from April 2017 to March 2018
 - i. If you wish to pay your Subscription by Direct Debit there is a £20 administration charge. If you paid by direct debit last year, the new amount as shown on your invoice will automatically be taken out of your bank account, based on last years bank details.
 - ii. If you are not paying by direct debit but would like to, please contact the office and we will provide you with a direct debit mandate form.
 - iii. Please be aware that once you have started paying by Direct Debit you have joined for the full year and are committed to paying the full amount due for the 12 month period, ie all 12 monthly Direct Debit payments on your account.
- Please be aware that the club will not issue any refunds, for any period where members are unable to play due to health reasons or any other prolonged absence. It is recommended by the club that members take out golf insurance that will reimburse membership fees.
- In accordance with club rules, if a member has not paid the appropriate subscription by 30th April 2017, and has no extended payment period other than the direct debit scheme which has been agreed with the Office, that member will be deemed to have resigned. In order to rejoin the club, the full years subscription will be due, plus the £10.00 administration charge due.
- Diaries and Membership Stickers will be available following receipt of subscription or on the successful collection of the Direct Debit payment due on 1st April 2017. Collection is from the Office (9am to 5pm Monday thru Friday) or the bar outside office hours. Please be aware that we do not post these.
- Please notify the Office in writing if you **do not** intend to renew your membership.
- Payment can be made by Cash, Cheque or Bank Transfer. Cheques should be made payable to :- Diss Golf Club. Please contact the Office for Bank Transfer details.
