**Open to Lady Members, Gentleman Members and Professionals of Clubs who are affiliated to the Norfolk County Golf Union, and other Professionals who are attached to Clubs and/or members of the Norfolk PGA, in pairs of any combination.**

If one of any pair is unable to play a substitute will be allowed, up to the day of the competition, provided the substitute satisfies the conditions above and produces a current certificate of handicap.

Professionals play from Scratch, Ladies and Gentlemen from their CONGU handicap. Differential strokes will be given dependent on the differences in SSS between men's and ladies cards. Ladies drive from LGU tees. **All handicaps must be active.**

**Half** combined handicaps allowed: **maximum** allowance **18**. The men's card will be used.

Ties will be decided on the last 9, 6 or 3 holes.

Entries may be limited at the discretion of the Committee. If entries exceed the limit, pairs with highest aggregate handicaps will be eliminated, by ballot if necessary.
