Notes regarding Application for Membership

1. The application should be proposed and seconded by members of at least two years standing.
2. The Proposer and Secunder are responsible for the Applicant and must ensure that the Applicant is instructed in the Rules and etiquette of golf and Rules and Bye Laws of Buckingham Golf Club Ltd, including the Dress Code.
3. It is the responsibility of either the Proposer or Secunder to accompany the applicant to the appropriate membership interview evening.
4. Applicants who do not have a Proposer and Secunder may tender a letter of introduction from their current or previous club instead.
5. Applicants who do have a Proposer or Secunder and have not previously been a member of a golf club should enclose a letter with the application form, advising of this.
6. Details of applicants for membership are posted on the Club notice board for at least 14 days prior to the applicant being interviewed by the Management Committee.
7. To qualify for Junior Membership, applicants must be aged under 18 on 1 March in the year of membership.
8. No new member shall enjoy membership until his or her Entrance Fees (if any) and Subscription has been paid, except by express permission of the Club Manager.
9. If there are no vacancies for Full Membership, applicants may be offered Membership in the category "Social Awaiting Golf" if their application is successful, until a vacancy arises for Full Membership. Social Awaiting Golf membership allows use of all Clubhouse facilities as well as the practice ground and putting green. However, in order to play golf, payment of the appropriate Green Fees will be required as well as compliance with the conditions regarding visitors, which require play with a member at weekends.
10. **By completing and signing this form, applicants explicitly consent to Buckingham Golf Club Ltd obtaining, recording and holding their personal data (including sensitive data) solely for Club purposes.
