

**THE GOG MAGOG GOLF CLUB**  
**BYE-LAWS**  
**2016**

| <b>Service of Alcoholic Liquor</b> |   |
|------------------------------------|---|
| 1.1                                | All arrangements for the purchase and supply of alcoholic liquor shall be such and only such as are permitted by law, as are decided from time to time by the Management Council of the Club ('the Council') and as are duly notified in the manner prescribed by law.  |
| 1.2                                | Without the previous consent of the Council no Member or visitor may bring any alcoholic liquor into the Clubhouse or Half Way House for consumption on the Club's premises.  |
| 1.3                                | Intoxicating liquor may only be supplied, for consumption on the premises, to persons who have attained the age of 18 years and who are:  |
| 1.3.1                              | Members of the Gog Magog Golf Club.   |
| 1.3.2                              | A bona fide playing guest of a Member who shall have their name entered in the Green Fees Visitor Book in the Professional's Shop by the member who will have paid their Green Fee.   |
| 1.3.3                              | Members of visiting teams engaged in fixtures against the Club.   |
| 1.3.4                              | Any person (not being a Club Member or playing guest of a Club Member) taking part in a tournament or competition held at the Club and organised either by the Club or by any accredited golfing union and the officials of any such tournament or competition.   |
| 1.3.5                              | Bona fide persons, who have a genuine reason for attending the Gog Magog Golf Club, who have paid a green fee and who intend to or have played golf at the Club, but only during the period covered by the Green Fee.   |
| 1.3.6                              | Professional Golfers visiting the Club and Secretaries and Captains of other affiliated Golf Clubs.   |
| 1.3.7                              | Non Members attending functions organised by a member of the Club.  |
| <b>Visitors</b>                    |   |
| 2.1                                | Visitors' Books shall be kept in the Clubhouse and in the Professional's shop or such other place on the Club's premises as the Council considers desirable.  |
| 2.2                                | A visitor introduced by and playing with a Voting Member (as defined in Rule 4.1. of the Rules of the Club), a Young Member (M) or Young Member (L) (as defined in Rule 7.), may, on payment of a Green Fee, paid by the member and on having his or her name entered in the Visitors' Book kept in the Professional's shop (or such other place as aforesaid), play on the Courses and use the Clubhouse during his or her visit, which shall be in all respects subject to Rule 9. of the Rules of the Club, to these Bye-laws and to the Regulations of Play. No Member may introduce more than two playing visitors to play on a Course that on the day is reserved for 2- and 3-ball games (except for the express purpose of playing foursomes only, when three may be introduced) or more than three playing visitors to play on the Unrestricted Course only. |
| 2.3                                | No visitor may be introduced more than <b>six times per calendar year</b> .   |
| 2.4                                | Visitors cannot play before 2.00pm on a Saturday or before 10.00am on a Sunday.   |
| 2.5                                | Only Juniors aged 12 and over with a CONGU handicap may introduce an adult or junior visitor on payment of a green fee providing that visitor also holds a CONGU handicap. <b>Only one visitor</b> introduced by a junior is permitted at any one time. At no time may juniors under the age of 12, or older juniors with a CLUB handicap or with no handicap, introduce a visitor. It should be remembered that the Junior Member is responsible at all times for the behaviour of the visitor and adherence to the dress code.  |
| 2.6                                | A non-playing visitor's name <b><i>must</i></b> be entered in the Visitors' Book kept in the Clubhouse.   |
| 2.7                                | Playing visitors not introduced by and playing with a Voting Member, a Young Member or a Junior Member under this Bye-law may be admitted at the discretion of the Secretary  |

|     | Manager, a Member of the Council or of the Men's/Ladies' Committee or (in the absence of all such persons) the senior Professional and must ordinarily be playing members of a United Kingdom affiliated golf club or other officially recognised golf club. The visits of all such visitors shall be subject to the provisions of Bye-law 2.2.  |
| 2.8 | All visitors, including teams playing matches against the Club and visiting golfing societies, admitted under this Bye-law may during their visit and as permitted by law buy alcoholic liquor at the bar as per Rule 1.3 above.   |
| 2.9 | Prior agreement with the Secretary Manager is required to hold any kind of society meeting, formal or informal.  |
|     | <b>Dress</b>   |
| 3.1 | <p><b>MEN:</b></p> <p>In the clubhouse:<br/>Whereas "appropriate dress" will be left to the judgement of individuals, the following items of clothing are widely considered inappropriate/unacceptable:</p> <ul style="list-style-type: none"> <li>• Stone washed, faded or distressed denim</li> <li>• Cargo shorts, ¾ length trousers</li> <li>• Sports shirts other than collared golf shirts</li> <li>• Trainers</li> <li>• Flip Flops</li> </ul> <p>N.B. Golf shoes of any kind are not permitted in the lounge (other than the spike bar) or dining room</p> <p>On the course:<br/>As with the clubhouse, "appropriate dress" will be left to the judgement of individual members. However at this time, the following items of clothing are widely considered inappropriate:</p> <ul style="list-style-type: none"> <li>• Blue denim</li> <li>• Cargo shorts, ¾ length trousers</li> <li>• Track Suits, Jogging Suits and variants of these</li> <li>• Collarless Tee Shirts</li> <li>• Training or cricket shoes</li> </ul> <p>In the case of children of members attending golf lessons or in the company of guardians both on the golf course or in the clubhouse a further degree of latitude should be encouraged.</p> <p>In matches where golfers are representing the Club, it is expected that Club Dress will be adopted. Where a specified dress code is required for functions in the clubhouse, this will continue to be communicated in the usual manner.</p> <p>Members are expected to ensure that their guests are appropriately dressed.</p> |
| 3.2 | <p><b>LADIES:</b></p> <p>In the clubhouse:<br/>Smart casual dress which includes blue denim.</p> <p>On the course:<br/>Ladies should wear appropriate golf clothing including golf shoes. The choice will be left to the individual but blue denim is not acceptable.</p> <p>Matches:<br/>Ladies are expected to wear Club uniform: Navy trousers, ¾ length trousers, shorts, or skirts.</p>   |

|     | White shirt & Blue Club sweater when representing the Club.<br><br>Members are expected to ensure their guests are appropriately dressed. In the case of children of members attending golf lessons or in the company of guardians both on the golf course or in the clubhouse a further degree of latitude should be encouraged.   |
|     | <b>Junior Members and Visitors under 16</b>   |
| 4.1 | Junior Members under 16 and also visitors under 16 accompanied by a Member or adult visitor may use the lounge and may visit the bar to buy soft drinks and/or food, but they must not remain at the bar or in the spike bar.   |
| 4.2 | The provisions of Bye-law 4.1. may be relaxed by the Council during Junior competitions.  |
|     | <b>Dogs</b>   |
| 5.1 | No dogs are permitted in the Clubhouse, other than bona fide guide dogs.  |
| 5.2 | No dog is permitted on any part of the Courses or of the surrounding land unless it is on a lead.   |
| 5.3 | Fouling of the Courses or of the surrounding land is not permitted. Members and visitors who bring dogs to any part of the Club's premises are responsible for clearing up after the dogs. Any Member or visitor who fails to do this will be banned from the Courses and the surrounding land for a period to be determined by the Club's Disciplinary Committee as set out in Rule 10 of the Rules of the Club. |
|     | <b>The Health Act 2006</b>  |
| 6.1 | The Club's policy under this Act ('the Act') is set out in the notice headed 'SMOKE-FREE POLICY' and is binding on Members to the extent required by the Act.   |
| 6.2 | To the same extent all Members shall be liable under Rule 10 of the Rules of the Club for any contravention by them, or by any visitors introduced by them, of the provisions of the Act or of any regulations made under the Act.  |
|     | <b>Notices</b>  |
| 7.  | No notice of any kind shall be displayed in the Clubhouse except by authority of the Management Council or Secretary Manager. Members shall not advertise goods or services.  |
|     | <b>The Club's Disciplinary Obligations</b>  |
| 8.  | For the removal of doubt, Rule 10 of the Rules of the Club shall be the basis on which the Council enforces any disciplinary obligation imposed on the Club in relation to members under the general law.   |
