Club Membership Insurance Policy

Your golf club has teamed up with Golfplan to provide members with a fantastic new policy that will run alongside your annual golf subscription, and is designed to protect members whilst playing or practicing golf at any golfing facility worldwide.

New for old golf equipment up to £2,000

We will replace the items new for old no matter the age. (£35 excess per claim. No excess on a total loss claim, GPS/rangefinders the excess is the first £100). Equipment cover includes 24hr theft of equipment from a locked car boot and in-flight transit overseas. Theft or attempted theft from a vehicle is subject to forced or violent entry or exit. Members will be covered for loss, theft and damage.

Public liability up to £5,000,000 (No excess)

World-wide legal liability to third parties for bodily injury whilst playing or practising golf at a golfing venue. Members will be covered if they hit someone with a ball, golf club or buggy.

Personal accident under 70's – up to £50,000 (No excess)

Plus hospital benefit £100 per day maximum of £1000 after 14 days of hospitalisation reached. Bodily injury resulting in death or total and irremediable loss of sight in one or both eyes or of one or more limbs. (Juniors – death only cover £2,500). Personal accident over 70's – up to £10,000 (No excess).

Third party accidental damage – up to £2,000,000 (No excess)

Reimbursement for repair of third party property unintentionally damaged by you whilst playing or practising golf at a golfing venue.

Club membership fees up to £1,800 (1st month excess)

Reimbursement of club membership fees following an accident or sickness rendering you unable to play golf. Over 70's excluded.

Hole-in-one up to £175 – Under 18's £50 (No excess)

Reimbursement of the cost of a round of drinks at the golfing venue immediately following a game of golf in a recognised competition when a hole-in-one has been achieved.

Personal effects – up to £600 (£35 excess)

For the cost of repair, reinstatement or replacement of your club member's personal effects which are stolen from, or which are damaged by fire, whilst in a secured locker in the changing rooms at a golfing venue.

Geographical Limits

This insurance is extended to include worldwide cover, for all benefits, for a maximum period of 120 days during the period of insurance. Members of the United Kingdom Armed Forces on overseas duty are exempt from this 120 days limitation.

Tournament entry fees – up to £150 (No excess)

For the non-refundable portion of a golf tournament entry fee when cancellation is due to an unexpected, unforeseen sickness or accidental injury that renders your club member, or your club member's partner in a doubles competition, unable to play golf.

Overseas Equipment Hire – up to £200 (No excess)

Hire of replacement golf equipment in the event that your club member's golfing equipment is delayed or lost in transit whilst travelling to an overseas destination or, is delayed or lost in transit whilst travelling by air within the United Kingdom.
