

## PAY YOUR GOLF SUBSCRIPTIONS THE EASY WAY BY DIRECT DEBIT



- Members may now apply to spread the cost of their annual subscription over a 12 month (max) period. The club has arranged with Zebra Golf Finance ([www.zebrafinance.com](http://www.zebrafinance.com)) to provide an **Instalment Plan** for members.
- There is small administration charge of 6.0% which will be added your monthly repayments
- To apply, go to [www.zebragolffinance.com](http://www.zebragolffinance.com) (**please read the schedule below before commencing your application**) click the **Apply for Finance** button, scroll through the list of clubs and select your club. Complete the details required including the amount of the subscription and submit.
- Your application will be credit assessed but unless you are under 18 or over 90, in a bankruptcy situation or are under a voluntary arrangement your application should be accepted and you will very shortly afterwards receive by e-mail a fully documented agreement. Please read this carefully and when you are satisfied you wish to proceed please autosign and submit it.
- You then have a 14 day period in which you can cancel the application. If Zebra do not hear from you in this time then 18 days after you submitted the completed application your first payment will be taken.
- **PLEASE NOTE THE FOLLOWING SCHEDULE**
- The on-line portal will open on **January 1st 2018**
- In order to ensure that your first instalment payment can be collected in February please ensure that you have submitted your completed application by **6th February**. Otherwise please complete the form as soon as possible.
- For late starters shorter terms are available. Please contact the office for details.
- At any time, you can choose from the shorter terms available.

Please note that the Instalment Plan is a loan for the full subscription year and you must complete all your instalment repayments. You are under no obligation to proceed with this application and there is no charge for applying.

If you do not have an e mail facility contact the club office and they will arrange for a paper application form to be sent to you.

**REPRESENTATIVE EXAMPLE:** Credit Amount £1,200. 12 monthly instalments of £105.90 each including an Administration Charge of £5.90. Cost of Credit £70.80. Total Repayable 1270.80. Representative 11.3% APR.  
Example based upon annual subscription fee of £1,200 and 12 month instalment option. Admin charge of 5.9% applies to all monthly options

For Herefordshire GC the rate of 6.0% applies for all terms..
