2. MATTERS ARISING

GW stated that 5.4 was an approximate cost making various assumptions and the cost is to be

confirmed and approved at a later date.

3. TREASURER'S REPORT

JF presented a copy of the accounts for the 12 months ended 31st December 2014 for approval.

JF reported that the accounts were satisfactory but commented on the disappointment of the catering profits. It is felt that there is room for improvement and various measures have been put in place i.e. reduction of waste, tighter stock control, checking of staffing structures. Meetings have been held with James regarding these matters. DW informed the committee that on various functions already this year the kitchen had not been open or sufficient supplies available. PF replied that this was lack of communication between the person responsible for the function and the kitchen. A suggestion was made that a Blackboard in the kitchen with all the

events for the coming week might help.

A list was given to committee members requesting attempts be made to contact these members. ALL 3.7 Another important key to the budget is the reduction in the Rates that the club get from the West Somerset District Council. JF informed the committee that a letter had been received giving notice that this might be withdrawn next year. 3.8 It has been agreed that there will be a change in the membership year; it is proposed that the year will change from January to December, to April to March. PF to prepare a proposal to this effect which will be displayed on the notice board, explaining that next year's subscription will be for 15 months and will be paid in two equal amounts due in January and July 2016 PF 3.9 After some discussion It was decided to include a percentage increase for staff in the budget.
