



Historic merger finalised

An update from the Ladies' Golf Union and The R&A

We have great pleasure in writing to inform you that the merger of the Ladies' Golf Union (LGU) and The R&A has been finalised and will come into effect from 1 January 2017.

The merger of the two governing bodies is a historic and hugely exciting step which will enable us to support golf and speak with one voice for all those who play – women and men and girls and boys.

A great deal of work has been carried out over the last year to bring the merger to completion and we would very much like to thank everyone who has played a part in the process and particularly the national associations, LGU affiliated clubs, partners and sponsors for the tremendous support we have received.

Integration

The integration of the two organisations puts us in a better, stronger position to realise our collective vision for growing the game of golf around the world and our combined resources and staff expertise will help us to achieve our shared aims for the development of golf.

The completion of the merger is a progressive and important move for the development of women's golf, including increasing girls' and women's participation and encouraging more families to enjoy golf as a recreational activity. Bringing the two organisations together creates a platform that will allow us to develop our aspirations for women's golf on a global stage and encourage more girls and women to play golf and become members of golf clubs.

Business operations

The LGU's business operations and its members of staff have been integrated into The R&A's group of companies and an agreed governance structure has been implemented to give LGU Board members representation on relevant R&A Committees. The LGU building on the Scores in St Andrews will be utilised by the merged organisation and will be included in a review of R&A facilities.

Championships

The R&A will also assume responsibility for staging the LGU's championships and international matches next year and we are delighted to be able to offer leading professional and elite amateur golfers opportunities to play in a world class series of events. The Ricoh Women's British Open will continue to be managed by IMG under the existing agreement with the LGU.

Information about the LGU's championships and international matches is being integrated into the Championships section of The R&A website www.RandA.org. This will include online entries, live scoring, competitor information, history, a list of previous winners and event archives.

Subscriptions

The merger will also see the phasing out of the LGU subscription, currently £2.50 per member, which is collected from women members of golf clubs affiliated to the LGU. The subscription will continue to apply in 2017 but will be phased out thereafter. The subscriptions collected in 2016 and 2017 will be used exclusively to help fund LGU operations.



The benefits of the merger

What does the merger with The R&A mean for the LGU?

The LGU's business operations have been integrated into The R&A's group of companies and the merger takes effect from 1 January 2017.

The two organisations' resources and staff expertise will be combined to focus on the achievement of shared aims for the growth and development of women's golf and the staging of world class championships and international matches each year.

What will happen to the LGU's Championships and International Matches?

The R&A will also assume responsibility for staging the LGU's championships and international matches next year and will integrate this within a full schedule of events. The objective is to give leading professional and elite amateur golfers opportunities to play in a series of world class events.

The Ricoh Women's British Open will continue to be managed by IMG under the existing agreement with the LGU.

What will happen to the LGU website?

Key historical and organisational information about the LGU and the merged organisation will be displayed on the R&A website www.Randa.org. Information about the LGU's championships and international matches is being integrated into the Championships section. This will include online entries, live scoring, competitor information, history, a list of previous winners and an event archive (where available). Followers of the LGU social media channels will be referred to the R&A equivalents which will feature a programme of content about the merger and LGU championships and development activities.

What will happen with overseas associations who are affiliated to the LGU?

Overseas associations will be able to affiliate to The R&A and will be contacted in the New Year.

Will you update LGU stakeholders on the progress of the merger?

A series of progress updates will be communicated to the LGU's national organisations, affiliates and partners in the course of 2017.

What will happen to the LGU's staff members?

The LGU members of staff have accepted positions with The R&A and will begin their tenure with the organisation from 1 January 2017. They will join relevant departments working in The R&A's current offices.

Will the LGU Board members be invited to join R&A committees?

An agreed governance structure has been implemented to give LGU Board members representation on relevant R&A Committees and this will take effect from 1 January 2017.

Is the LGU office closing?

The LGU's office at The Scores has been acquired as part of the merger and will be utilised by the merged organisation.

Will the LGU subscription still apply?

The LGU subscription, currently £2.50 per member, which is collected from women members of golf clubs affiliated to the LGU, will be phased out after 2017.

The subscriptions collected in 2016 and 2017 will be used exclusively to help fund LGU operations.
