Application for Membership – Privacy Notice

Whickham Golf Club Limited, herein referred to as “the Club” respects an applicant’s personal information and undertakes to comply with all applicable data protection legislation currently in force.

Under the legislation an individual has the right to be informed about data the Club holds about them and how it is used. The following information summarises this so far as an application for membership is concerned:

How information about you on your application form will be used

So that we can process your membership application.

Who do we share your application for membership information with

With the Club’s Office Staff, who will have access to your full details on your application form, in order to process your application.

With the Club’s Management Committee who agree acceptance of an application.

Part 1 of the application form will be displayed on the Club Notice Board for a period of 14 days and will be available for perusal by the Club’s membership.

Whenever we share your information we do everything we can to make sure it is protected from misuse or loss.

How long do we hold your application for membership information

If you decline to accept membership when it is offered to you, or in the unlikely event of your application not being accepted, your information will be securely destroyed.

If you accept membership your information will be entered into the appropriate location in the membership records and will remain there until there is no business, legal or historical reason for keeping the information.

When you become a member

You will receive more detailed information on the subject of data protection, with regard to your membership.
