

# Proposes Changes to the Carton House Men's club constitution

To be voted on during the AGM on 15<sup>th</sup> February 2022

## Proposed Change 1

### 1. DEFINITIONS

**Ordinary Men's Member** is a 7 day **or 5 day** Men's Member who is not an Intermediate or Junior member.

## Proposed Change 2

Throughout this entire document, all references to "GUI" should be replaced with "Golf Ireland"

## Proposed Change 3

### 7. RESPONSIBILITIES OF THE MENS COMMITTEE

7.9.1. With the nominees consent the Vice-Captain will propose two nominees for the office of incoming Vice Captain on or before the 30th of October **from the list of 7 day members**.

## Proposed Changes 4

### 8. MENS COMMITTEE STRUCTURE AND MEMBERSHIP

8.1. The Men's Committee shall consist of the Officers, the immediately previous captain ex-officio and up to nine elected members of the Men's Club. Only Ordinary **7 day** Men's Members are eligible to be nominated, elected or appointed as Officers or committee members.

8.3. Nominations (with written consent of the nominees) for the election of committee members can be made by either the Men's Committee or two Ordinary **7 Day Men's Members** of the Men's Club provided a member may only be nominated as Officer if he has been a member of the Men's Club Committee for at least two years in the case of Captain and Vice-Captain, and at least **one year** in the case of **Secretary** and Treasurer.

8.9. The Men's Committee shall decide on the conditions under which **all** members may play in Men's Club competitions.

## Proposed Changes 5

### 18. ANNUAL MEN'S CLUB LEVY

18.6 The Annual Men's Club Levy year shall be the calendar year from 1 January to 31 December for members joining or re-joining for the calendar year. The Men's Club Levies shall be payable **at the same time as the Annual Carton House fees.** ~~in advance or on the joining date. For calendar year re-joiners, the levies must be paid before the 1st February or on such date as may be determined by the Men's Club Committee. For members re-joining for the 12month year, July 1st to June 30th, the Men's club Levy shall be payable in advance on or before the 30th June.~~

18.8 Any Men's Member whose Annual Men's Club Levies is unpaid on March 1st for Calendar year re-joiners ~~and for members re-joining for the 12 month year July 1st to June 30th is unpaid on July 1st~~ may NOT compete for any Men's Club Competition, or vote at any meeting of the Men's Club and will be suspended as a Men's Member ceasing to enjoy any rights and privileges of Membership until such time as payment is made.

## Proposed Changes 6

### 24. OPERATIVE DATE

24.1 This Constitution will take effect from the date of approval being the **2021 season AGM** - Striving to build a "Carton" tradition of friendship and hospitality to rival the best in Ireland.
