SL brought the sub-committees motion to change the qualifying criteria for board and knockout competition. AS reminded that the original qualifying criteria was brought in at a time where golfers with dubious handicaps were joining clubs winning the major championships then leaving. At the current time where competition entry is dropping putting in more stringent entry requirements was felt to be putting up barriers towards competing. GB proposed a counter motion of reverting to 12 months with 6 qualify rounds and no competition rounds in the period. It was agreed that the current criteria should be kept. An email should be sent to all members making them aware it is their responsibility to ensure they have the requisite competition and qualifying rounds in place to compete and the comps committee would only check the winners to ensure criteria is met.

GB – raised the issue of one of the photo's on the new website being of the old putting green and therefore inaccurate.

PG – OOB on 11 runs too long, can be punished for slightly errant shots during summer conditions with balls kicking off the side of the green and running OOB. Can consideration again be given to this area.

With the club pushing the practice facilities and being used in the evenings during the winter months the lack of lighting to both the route from the car park to the range and from the ball machine to the range. Can something be done about this as potentially dangerous.

Can a swisher be put on the putting green? When warming up and practicing before playing in the mornings the green is often covered with leaves and general detritus meaning the area cannot be used for its intended purpose.
