#### House

The position of the air shoe cleaner was discussed. This was installed primarily for shoes, but with so many members and visitors now using electric trolleys, we have to re-think this facility to make it more comfortable for users. It was proposed to extend a concrete plinth in between the external walls of the snooker room and changing room to both accommodate the Cycle Rack and a new larger grid to stop the path becoming so muddy and unsightly. Other smaller jobs will be carried out shortly.
