Notes Regarding Application for Membership (Proposer & Secunder)

3. The Proposer and Secunder are responsible for the Applicant and must ensure that the Applicant is instructed in the Rules & Etiquette of Golf and the Regulations & Bye Laws of Stourbridge Golf Club, including the Dress Code.
4. It is the responsibility of either the Proposer or Secunder to accompany the applicant to the appropriate Membership Interview.
5. For Applicants who do not know any current Stourbridge Golf Club Members the Applicant may tender a letter of introduction from their current or previous club instead, along with two suitable references.
