<b>FAIRWAYS</b>	<b>In full time employment or self-employed.</b> Fairway's members are entitled to 50 x 9-hole rounds which can be used to play 9 Holes (1 credit) or 18 holes (2 credits). Can represent Club in matches and play in all competitions only 7 days after BRS sheet has gone live. <b>(Must sign in at Pro Shop each time you play).</b>	<b>£815*</b>
<b>COUNTRY</b>	Must live 20 miles from Club by the AA road map. Can only play in Medals & Stableford Comps. Maximum Handicap requirement of 24 for men and 30 for ladies.	<b>£550</b>
<b>OVERSEAS</b>	Must live beyond UK for six months or more in any subscription year.	<b>£780</b>
<b>PART PLAY (20 years membership)</b>	To include social membership and 12 rounds of golf (or 24 half rounds) with ability to play in non-cup medals or Stableford competitions and Mixed competitions. <b>Can only play after 12.00 at weekends.</b> <b>(Must sign in at Pro Shop each time you play)</b>	<b>£420*</b>
<b>TWILIGHT Full Year</b>	Access to course after 4.00p.m. April to October & after 1.00 p.m. November to March, 7 days a week and includes 12 months social membership.	<b>£900</b>
<b>TWILIGHT Summer</b>	Access to course after 4.00 p.m. April to October, 7 days a week and includes 12 months social membership.	<b>£575</b>

#### **PAYMENT TERMS (\*Standing Order Available)**

Members paying by Standing order will be required to pay for their locker, trolley space, EGU fee and first monthly subscription payment on 1<sup>st</sup> June 2020 followed by 11 monthly payments of the above-mentioned amounts commencing on the 1<sup>st</sup> July 2020. (12 monthly payments include £50 administration fee.) It is the responsibility of members to ensure that standing order arrangements are put in place by 1<sup>st</sup> July 2020 failing which **the full outstanding balance will become immediately payable**. Those members paying by one single payment will pay the discounted payment in advance rates. Members should be aware that once entered into there is a **legal commitment** to pay the entire entrance fee /subscription even if settlement is by way of the monthly payment options.
