**Open Competitions**

Open competitions have specific entry requirements. These requirements include:-

- Age on the date of the competition: 55 or over for senior opens, 18 or over for remaining adult opens. Junior opens are limited to those who are 17 years old or under on the 1st January of the year in which the competition is played.
- Competitors are to provide evidence of a WHS Handicap Index in order to win any Open competition prize.
- A maximum handicap index limit may apply.
- The organiser reserves the right to refuse or cancel any individual open booking at their own discretion without any recourse and any payments made will be refunded.
- In the event of play being suspended due to adverse weather conditions, the klaxon will sound. All players MUST mark their ball and leave the course in accordance with Rule 5.7.
