## 9. ELECTION OF MEMBERS

9.1 The election of members shall be carried out by Council and shall be by secret ballot.

9.2 Limits set out in these Rules for the maximum number of members in any category of membership shall not be exceeded. Council has discretion on numbers in any category where a maximum limit has not been set out in these Rules, and shall also have the discretion to close the membership of The Club from time to time, as it may consider necessary.

9.3 The procedure for the election of members shall be as follows.

9.3.1 Existing golfing members wishing to upgrade/change their category of membership must apply by letter to The Club Secretary by the stipulated date. Consideration of any application received after the closing date is at the discretion of Council.

Applications for membership from persons not already golfing members of The Club, excluding applications for Honorary or Temporary Honorary categories, must be proposed by a Full member and seconded by another Full member. If the proposer or seconder is a member of the Ladies Golf Club, time as a Lady member will count in lieu of time as a Full member for this purpose.

9.3.2 Officers of The Club and members of Council shall not be entitled to propose or second a candidate for Full or Five-day membership but the Captain of the Men's Golf Club and the Captain of the Ladies' Golf Club shall each have the right to nominate one person for membership without the requirement for a seconder.

9.3.3 A member proposing or seconding a candidate for membership must know the candidate personally, and both the proposer and seconder will write a letter of reference addressed to the Council outlining his / her personal knowledge of the candidate.

9.3.4 The proposer of a candidate for election must obtain an "application for membership" form from The Club Secretary and must return the form duly completed and signed by the proposer and seconder, together with both letters of reference, to The Club Secretary by the stipulated closing date. Acceptance of nominations received after the closing date will be at the discretion of Council.

9.3.5 Council shall arrange for the names and addresses of the candidates selected to go forward to the election process to be posted in the Clubhouse for at least fourteen days before the meeting at which the applications will be considered.

9.3.6 The Secretary/Manager shall inform all successful candidates in writing and shall forward to them a copy of The Club Rules. The candidate shall become a member of The Club, and shall be entitled to the benefits and privileges of such membership and be bound by its rules, when the appropriate payment has been received by The Club.

9.3.7 If the requested payment has not been made within one calendar month of the date of the request, the election of that member shall be void unless the candidate shall satisfy the Council that the delay in payment was due to some unavoidable cause.

9.3.8 The Secretary / Manager shall inform all unsuccessful candidates in writing and shall advise them that a further application for membership must follow the above procedure again.

9.3.9 The proposer and seconder of a candidate who is elected to Full or Five-day membership will not be eligible to propose or second any candidate for any of these categories for a period of three calendar years following the year of election to membership of that candidate.
