What information do we collect about you?



We collect information about you when you join our Golf Club or voluntarily sign up to receive updates or newsletters regarding the club. This may have been collected from our website, social media, or data capture forms. We only collect the relevant information required to fulfil our contractual obligations which include being able to contact you for the purpose of sending out subscription renewal notices, AGM information, administering handicaps and competitions, and any club/course updates.

How your information about you will be used

We use the information collected to allow us to fulfil our contractual obligations to you as a member which may include contacting you by post. In order to fulfil our contractual obligation to you as a member, we share your information with external and internal data processors (Club Systems and CONGU), however your personal data is administered internally by data controllers who adhere to the policies and procedures of the golf club.

Marketing

We would also like to be able to correspond with you regarding activities, events and competitions by way of post, telephone and email. We do **NOT** share your data with external marketing companies who would contact you this way. If you do not wish to receive any marketing by these methods, you can opt out at any time by contacting the Manager.

Individual Rights

You have the right to request a copy of the information we hold about you. If you would like a copy of this information, please email or write to the Manager and we will be able to provide you with a copy. We want to make sure your personal data is accurate and up to date, therefore, you may ask us to correct or remove information that you think is inaccurate or you wish for us not to have. At the time of collecting data, you have the right to object to the club holding certain information about you.
