All fairways will be vertical drained through out the coming weeks, we have hired a 2.4meter machine which is pulled by a tractor, it will punch 16 inch holes in the fairways, which we hope will aide surface water to be able to drain as the top surface will be broken up, we believe this has never been done before on the course, The holes will remain opethis time if it is successful, we hope it will become an annual maintenance to be carried out.

The greens team will carry on with there winter maintenance plan of cutting and spraying, which we are hopeful will help us through the winter months and take us into the playing season in a great place. The project to re shape the cross bunker on the fourth hole has been shelved for the foreseeable future.

We have a new website which is now live. We are kin a positive place going forward.
