Saturday morning tee reservation.

I was a little surprised to see the 11th tee being reserved for the 8.45 swindle. How was this decision made, I would assume something so contentious would have been debated at Board level and voted on. If the issue was indeed voted on could you please publish the debate from the minutes of the meeting so the members can come to a understanding of how the decision was made.

Below I will list some points I would like to request answers too.

1. By moving the 8.45 swindle to the 11th doesn't this create problems for members who prefer to play a little later on, on Saturday mornings, the 1st tee is already reserved for the Ladies section and the 8.45 swindle on top of this closes the first tee for around an hour.

2. Why does the 8.45 swindle receive preference when most members have to book tee times.

3. Why do the other swindle groups particularly those on a Saturday morning not have the benefit of being able to block tee times so they can play in pre chosen groups.

4. Why has a decision been made that would seem to deliberately invite the accusation of favouritism. Surely the Chairman and the Board would be aware of how this comes across to the members when the Chairman's swindle are the main beneficiary of such a decision. Was any of the other swindle groups considered to be given the block booking.

5. The Chairman has graciously extended an invite for anyone wishing to join the 8.45 swindle to register their interest. If the numbers exceed 24 will you then open up a free draw of who gets to play, if not you are creating a club within a club.

My opinion is this, this seems to be the opposite of what Shirley Park golf club advertises itself to be, as friendly inclusive club open to all. "Some are more equal than others" all full members pay the same and all should be treated the same.

Please post on the forum to open a debate, on this issue I believe the Board have got this very wrong it would be interesting to get the views of other members.
